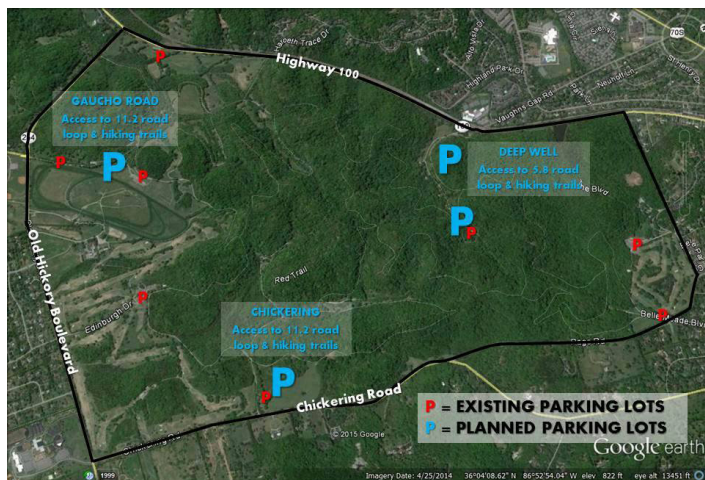

PAGE LOT CLOSURE

FROM MAYOR JIM HUNT . . .

You may have seen the October press release from Metro Parks announcing the November 1 closure of lot at Page Road and the entrance to Percy Warner Park. If not, here is the official release. . . .



PERCY WARNER PARK - PARKING IMPROVEMENTS

—Nashville, TN — Metro Parks and the City of Belle Meade announced today that the overflow parking area at the corner of Page Road and Belle Meade Boulevard will close on November 1.

Parks Director Tommy Lynch said the popularity of the park coupled with an increasing number of users is taking its toll on one of the city’s premiere destination parks. “We have an obligation to be good stewards of the land we manage,” said Lynch. “This is about protecting the parks’ natural and cultural resources for future generations, enhancing the user experience, while also being cognizant of those who live in the immediate vicinity.”

The City of Belle Meade presented a preliminary plan to the Parks Board that would convert the overflow parking space into a landscaped green space. However, there are still some steps in the process that need to be addressed before anything is final, said City of Belle Meade Mayor Jim Hunt. “This conversion will create a pleasing and more appropriate entrance to Percy Warner Park and also benefit the neighbors by adding to the beauty of the City of Belle Meade”

In addition to the parking that is available currently, future parking lots are planned behind Percy Warner Golf Clubhouse, at Gaucho Road near

the Steeplechase, at the Chickering Road entrance and in two locations at Deep Well off Highway 100. These sites were selected because they offer easy access to the trail and road systems, and parking can be integrated without significantly impacting the character of the landscape. The total number of new spaces in these lots is 150. Each lot will include a trailhead with map and a Portajohn and will utilize pervious surfaces. The Gaucho Road and Chickering lots will each include new connector trails to the Mossy Ridge (red) trail loop. —

History on the Page Lot. . . .

Since the late 1990’s, the City of Belle Meade and Metro have disagreed regarding appropriate use of the lot at the intersection of Page Road and Belle Meade Boulevard. The property, which consists of roughly one acre of land, lies within the jurisdictional boundaries of the City of Belle Meade. However, the land is owned by the Metro Parks having been given by Susan Warner for the “beautification and protection of the entrance” to Percy Warner Park. Until the mid-to late 1990’s the property was used for children’s soccer and football practice and pick-up games. After that – no one is sure when – the property began to be used for overflow parking for visitors to Percy Warner Park and certain non-visitors that used the lot as a starting point for a bike ride or run on Belle Meade Boulevard. Meanwhile, Metro Parks identified additional parking as a long range need of Percy Warner Park.

Since 2008, the Belle Meade Commissioners have worked with the Parks Board and the City of Belle Meade to reconcile their differences regarding use of this property. About 4 years ago, we began an effort to explore the circumstances under which Metro Parks might consider alternative uses for this Page Road property. Metro Parks made clear that before parking would end at the Page lot, alternative parking locations would need to be identified and developed. Furthermore, there would need to be a concerted effort to educate and inform park visitors of the alternatives available for parking elsewhere in the park prior to any change.

In the FY2012 Metro capital budget, the Parks department requested a capital appropriation to expand parking at the nine-hole golf course with a trail head connecting the park directly to the 5.8 mile paved route. The City of Belle Meade actively supported this appropriation that was ultimately approved. The project was completed in 2015 plus a number of other areas were identified for more parking and are now available. This effort is designed not just to replace the places lost at the Page road location but to create a net increase in parking throughout the park while at the same time distributing visitors more evenly to all entrances. The City of Belle Meade has and will stay supportive of multiple parking locations.

Even after conversion the property continues to be under the control of Metro Parks and its use will ultimately be designed to meet the intent of Susan Warner’s gift to the City.
