To RE or not to RE that is the question REcycle that is By Mayor Jim Hunt

In 2010, Belle Meade began a recycling program that encouraged residents to separate their recyclable materials from the trash. The approved materials were to be placed in black bags into clearly marked collection containers. The approved materials list called for paper (newspapers, magazines and cardboard boxes broken down), cleaned and rinsed plastic bottles, cleaned and rinsed tin and aluminum cans and very little else. Unfortunately, our current vendor reports that careless or unknowing combining trash

with recyclable materials render the entire Belle Meade recycle program useless.

One thought is that this happens because the resident has outsourced their recycle separation to housekeepers, landscape workers or children without adequate education of what is acceptable and what is not. If we don't correct this quickly, our recycle program will be discontinued. Please do your part. IT IS SIMPLE. Use a bit of common sense, too.

FROM MAYOR JIM HUNT - NEW STREET SIGNS IN BELLE MEADE



Have you ever questioned the spelling of Lynwood Blvd or Shepard Place? Are you sure it's not Lynnwood or Sheppard? Were the street signs too small and soiled to read them? Not now

Like 'em or not, Belle Meade is complying with another un-

funded federal mandate regarding sign height and length, font size of the lettering, reflectivity and historical significance.

While the residents are familiar with the names of our street, visitors and more importantly, emergency vehicles, need to have clear signage to quickly locate homes requiring immediate attention.

New regulations require standard signs of 9" in height for ground mounted street sign poles on roads with speed limits of 25 m.p.h. or greater. The 9 inch sign requires lettering height of 6 inches, and street names must consist of upper/lowercase lettering. In addition, the new regulations also require street name signs to have a High Intensity Prismatic reflective sheeting, which makes them much easier to see at night.

The size of the new street signs creates an overpowering appearance caused by the original narrow pole. A new pole, larger in circumference, mounted upon an attractive base, would lessen the disproportion. Coupled with the City's desire to retain the beautiful horses atop, the commissioners may consider phasing in sign borders, new poles and bases. Current federal requirements will not allow for historic logos to be part of the street sign but we will continue to monitor any changes in the law. While new, larger poles were originally considered, the cost was significant and can only be done in phases. Stay tuned for changes to be considered.

We are still receiving some calls about attempted scams. Residents are doing a great job by letting us know when they receive a scam call and thus


far there have been no known victims. Keep up the great work!

RECAP OF BOARD OF COMMISSIONERS' MEETINGS



The Commissioners took action on the following items at the **November 18, 2015** meeting:

Approved the low estimate of \$5,100 from Landscape Services to perform tree trimming on Belle Meade Blvd. medians as per Nashville Electric specifications.



- Approved a one-year extension of the Street Maintenance Contract with Gibbs Brothers Construction at the same pricing for labor, equipment, and materials.
- Approved a one-year extension of the Landscape Maintenance Contract with Landscape Services Inc. at the same annual pricing of \$57,900.
- Approved a request to declare the old street name signs as surplus property.
- Declined to approve an outside vendor for a glass recycle program.
- Deferred action on Ordinance 2015-8, Amend Stormwater Ordinance, on second reading.
- Deferred action on Ordinance 2015-9, Amend Section 12-103, Building Materials Standards, on second reading.
- Approved Ordinance 2015-10, Amend Section 5-105, Withdrawals from Accounts, on second and final reading.

Stormwater User Fees were due and payable upon receipt of the invoice. They are now **PAST DUE!** If you have not already done so, please remit payment to city hall.

Property Taxes are due on or before February 29, 2016.
