- Mrs. Patsy Harvey of 219 Jackson Blvd spoke in regards to changing the speed limit on her street from 30 miles per hour to 25 miles per hour. On April 10, 2017, a public bid opening was held for the 2017-2020 Solid Waste Garbage, Trash & Recycle Collection and Disposal Service Contract. Seven contractors received bid packets and five of these were present at the mandatory pre-bid meeting on March 31st. Three contractors submitted bids, as follows:
