 - 2. Consideration of Bids for Snow & Ice Removal Contract
 The specifications were sent to six contractors, but only one submitted a
 bid; Sammie Gibbs Construction. Gibbs had the contract with the City from
 2008-2012. Their unit prices for labor, equipment, and material are
 comparable to the current contract pricing.

- 3. Consideration of Bids for Street Sweeping Contract
 Two contractors received the bid specifications and submitted bids as follows:
 - Sweeping Corp. of America \$18,754.56 (Annual)\$1,562.88 (Monthly)
 - Clean Earth Collections \$22,212.00 (Annual) \$1,851.00 (Monthly)

Reardon and Smith recommended Sweeping Corporation of America. Payments for this contract are made from the State Street Aid Fund, whose revenues are from gas tax collections.

4. Consideration of Bids for Landscape Maintenance Contract
Six contractors were given the bid specifications, only one submitted a bid;
Landscape Services, Inc. (LSI). They have had the maintenance contract with
the City for 20 years. The 24-month contract price is \$132,000 which is an
increase of 14% of the price that has been in effect since 2012. The
contract will begin January 1, 2017 through December 31, 2018.

2. Consideration of Bids for Police Vehicles

The Police Department advertised and solicited bids for (12) police package vehicles to replace the Volkswagen Passats. Chief Eads received three bids from Ford and two bids from Dodge. The following represents the two low bids for the all-wheel drive sedan and two low bids for the front-wheel drive sedan.

Golden Circle Ford Jackson, TN 2017 Ford Interceptor AWD \$24,782.00 ea.

Nashville Chrysler Dodge Jeep Ram 2017 Dodge Charger AWD \$24,150.36 ea.

Golden Circle Ford Jackson, TN 2017 ford Interceptor FWD \$23,774.00

Ford of Murfreesboro 2017 Ford Interceptor FWD \$24,197.00

Chief Eads would prefer to purchase the Ford Utility AWD at the bid of \$27,676.00 ea. However, due to the elimination of the Hall Tax, the Chief recommends the purchase of (12) AWD Dodge Chargers from Nashville Chrysler Dodge Jeep Ram for a grand total of \$289,804.32.

Motion to approve Chief's recommendation of (12) AWD Dodge Chargers: <u>Thornburg</u> Second: <u>Weigel</u> Vote: Thornburg and Weigel for, Hunt and Bogle against. Motion failed due to lack of majority vote.
