#### NEW BUSINESS

Belle Meade Plantation - 5025 Harding Road (16081)
 Special exception - Enclosing fence.
 Building permit has been denied:

A. Construction and alteration of the Plantation under the zoning ordinance Appendix C, historic home or site, requires BZA approval.

#### Presentation:

L. Patterson presented on behalf of the Belle Meade Plantation and Alton Kelley, President. They would like to close off the Parmer Avenue entrance to the plantation with a fence.

#### Board Questions/Comments:

- Q. Does the fence continue on the other side of the driveway?
- A. It does.
- Q. So it is on both sides?
- A. Yes.
- Q. Why don't they just fill that area in with shrubbery if they are not going to use it for a driveway?
- A. Mr. Kelley just wants to continue the fence. I believe they had a permit and an approval to run that fence originally several years ago and they just want to continue.
- A. There has been a real problem with traffic coming out the back side of the plantation and the commissioners are sensitive to that.
- Q. How are they going to get the tents in?
- A. They will have to come in another way. They are going to close the back entrance off completely.
- Q. Are they going to remove the driveway?
- A. That has not been discussed.
- Q. They are going to put a fence up with a driveway but no access? No purpose for the driveway?
- A. I would imagine that they will remove that driveway where it connects to the street and maybe use the drive on this side for parking and run the fence straight across.

#### Audience Questions/Comments:

Charlie Atwood of 419 West Tyne Drive stated that he supported the fence after being involved indirectly due to his daughter and son-in-law living across the street from the plantation. The proposal to continue the fence would help solve some of the traffic and noise concerns that the neighbors surrounding the plantation had.
