


RESOLUTION 2015-01

NASHVILLE AND DAVIDSON COUNTY


BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE CITY OF
BELLE MEADE, as follows:

1. That the Mayor is authorized to execute an amended Mutual Aid Agreement previously authorized by Resolution 93-06, attached hereto as Exhibit A, a Mutual Aid Agreement under which the City of Belle Meade would provide the Metropolitan Government with supplemental law enforcement services within the boundaries of Percy Warner Park and Parmer Park.

MEMORANDUM OF UNDERSTANDING
between
The Metropolitan Government of Nashville and Davidson County
and
The City of Belle Meade

The parties of this Memorandum of Understanding (hereinafter "MOU") are the Metropolitan Government of Nashville and Davidson County, Tennessee acting through its agency the Department of Parks and Recreation (hereinafter "Parks") and the City of Belle Meade.

It shall be the intent of this Agreement to establish, promote, and maintain a continued and harmonious working relationship and cooperative effort between the Parks and the City of Belle Meade.

It shall be the purpose and the spirit of this Agreement, by the mutual and cooperative efforts of Parks and the City of Belle Meade, that effective law enforcement and a secure environment is provided within Parmer Park and on or about the property owned, operated, and maintained by the Metropolitan Board of Parks and Recreation. To further that purpose, Parks and the City of Belle Meade agree as follows:

- 1.) Members of the City of Belle Meade Police Department (hereinafter "BMPD") may exercise the law enforcement authority of a Metro Parks Police Officer (hereinafter "MPP") at Parmer Park.
- 2.) BMPD Officers may exercise law enforcement authority only while acting within the scope of their employment for BMPD and only within the Parmer Park, located at Leake Avenue & Zwieback Street, Nashville TN 37205;
- 3.) The law enforcement authority of the BMPD shall be the same as that set forth for Tennessee law enforcement officers by statute and common law of the State of Tennessee not inconsistent with this Agreement.
- 4.) BMPD will provide MPP access to all law enforcement records pertaining to any and all incidents occurring in Parmer Park.

- 5.) BMPD and MPP shall have reciprocal communication concerning any information, data, or knowledge of issues relating to criminal activity or officer safety within the geographical area set forth in Paragraph 2 above.
- 6.) BMPD understands that Parmer Park is an inclusive facility owned, operated and maintained by the Metropolitan Government of Nashville and Davidson County and shall be open to all visitors and residents for general park use and all recreational events hosted by Parks.
- 7.) By entering into this agreement Parks does not relinquish the right of MPP or the Metro Nashville Police Department's to exercise law enforcement authority in Parmer Park or on or about property owned, operated, and maintained by the Metropolitan Board of Parks and Recreation.
- 8.) This MOU may be terminated by either party upon thirty (30) days written notice to the other party.


