

ORDINANCE NO. 53-2


"AN ORDINANCE PROVIDING ADDITIONAL FIRE PROTECTION FOR RESIDENTS OF AND PROPERTY IN, THE CITY OF BELLE MEADE, BY AUTHORIZING CERTAIN NAMED OFFICIALS AND OTHERS TO CALL UPON THE FIRE DEPARTMENT OF THE CITY OF NASHVILLE FOR AID AND ASSISTANCE; AND GUARANTEEING PAYMENT FOR SUCH ASSISTANCE; AND PROVIDING FOR THE CERTIFICATION OF THE NAMES OF SUCH AUTHORIZED POWERS TO THE PROPER OFFICIALS OF THE CITY OF NASHVILLE, AND PROVIDING TWO CERTIFIED COPIES OF THIS ORDINANCE AND OF THE PERSONS AUTHORIZED TO CALL FOR ASSISTANCE THEREUNDER.

BE IT ORDAINED by the City of Belle Meade as follows:


SECTION 1. In order to provide additional protection of life, safety and property of persons resident in the City of Belle Meade, Tennessee, the Mayor, the Vice-Mayor, the City Manager of the City of Belle Meade, and the Chief, or acting Chief, of any private fire department which may be now or hereafter engaged to render fire protection to persons and property within the City of Belle Meade, are hereby expressly authorized to declare an emergency and to call upon the Fire Department of the City of Nashville, Tennessee, to send men and equipment to the City of Belle Meade to aid and assist in combatting fire within said City of Belle Meade.

SECTION 2. The City of Belle Meade hereby expressly guarantees payment of the sum of THREE HUNDRED (\$300.00) DOLLARS to the City of Nashville for each call or trip made by said Nashville Fire Department to the City of Belle Meade upon the request of such authorized person on behalf of the City of Belle Meade.


SECTION 3. Upon final passage and adoption of this Ordinance one certified copy of same shall be delivered to the Mayor, the City Attorney, and the Fire Chief of the City of Nashville, Tennessee. There shall also be furnished to the said officers of the City of Nashville, upon certificate of the City Recorder of Belle Meade, the names of the Mayor, Vice-Mayor and City Manager of the City of Belle Meade, and of the Chief, or acting Chief, of the private fire department engaged to render protection to persons and property in the City of Belle Meade; such list of names shall be kept current by the City Recorder of Belle Meade.
