

Resolution 1952-02

"BE IT RESOLVED, That the following items of repair and construction be undertaken by the City of Belle Meade and that the Inter-State Construction Company be directed to proceed with same pursuant to the terms of the contract now in force, the order heretofore given, and the letter of the City Manager dated March 10, 1952, except as to the amount of materials and labor to be furnished, and that the sum of Thirty Thousand (\$30,000.00) Dollars be appropriated for road and street construction and repair work in the City of Belle Meade for the year 1952, as follows:-

1. Belle Meade Blvd. west from Harding Road to Forsythe Avenue, Seal coat, 22,867 sq. yds.
2. Westview Ave. from Glen Eden Ave. to Lynwood Blvd. Mixed in place and seal coat, 5800 sq. yds.
3. Jackson Blvd. from Belle Meade Blvd. easterly to Harding Place, mixed in place and seal coat, 11,800 sq.
4. Leake Ave. from Belle Meade Blvd. west to City Limits, mixed in place and seal coat, 2445 sq. yds.
5. Chickering Lane from Chickering Road to City Limits, patch only, 3111 sq. yds.
6. Evelyn Ave. from Clarendon Ave. to Harding Road, mix in place and seal coat, 2178 sq. yds.
7. Bellevue Drive, South, from Bellevue Drive, East to Bellevue Drive, West, mix in place and seal coat, 2200 sq. yds.
8. Bellevue Drive, North, from Bellevue Drive, East to Bellevue Drive, West, mixed in place and seal coat, 2,022 sq. yds.
9. Bellevue Drive, East from Deer Park Drive to top of hill mixed in place and seal coat, 1800 sq. yds.
10. Deer Park Drive from Jackson Blvd. to Belle Meade Blvd. mixed in place and seal coat, 6822 sq. yds.
11. Royal Oakes Drive from Glen Eden Drive to Howard White's residence, patch only 2900 sq. yds.
12. East Brookfield Drive from Chickering Road 300 ft. north patch only, 600 sq. yds.
13. Omitted.
14. Deer Park Drive to Mr. Jo Gibson's residence. Clear trees and widen, 1600 sq. yds.
15. Patching entire townsite.
16. East Bellevue Drive from top of hill to Deer Park Drive


ditch, furnish and install culverts, 120 lineal ft. of 15 in. metal culvert and 60 lineal ft. of 18 in. metal culvert.

17. At the intersection of North Bellevue Drive and West Bellevue Drive furnish and install culvert, 36 lineal ft. of 18 in. metal culvert.
18. Not approved.
19. Forsythe Ave. ditch, furnish and install culverts, 68 lineal feet of 15 in. metal culvert and 36 lineal ft. of 18 in. metal culvert.
20. Intersection of Belle Meade Blvd. East and Tyne Blvd. correct drainage 556 sq. yds.
21. Belle Meade Blvd. East from Leake Ave. to Deer Park Circle, mixed in place and seal coat, 3,333 sq. yds.
22. Belle Meade Blvd. west in front of Mr. Jim Reed, Jr.'s, ditch and mixed in place, 444 sq. yds.
23. Belle Meade Blvd. west in front of Fred Harvey residence, furnish and install culvert, 64 ft. of 12 in. culvert.
24. Sheppard Place from Jackson Blvd. to end of pavement, open ditch on northerly side of road.
25. Howell Place from Jackson Blvd. to residence of Joe Byrnes, open ditch on northerly side, open drain in front of Byrnes', trim shoulder on south side of road and level shoulders.
26. Alley from Jackson Blvd. to Howell Place, install culvert and surface 567 sq. yds.


Estimated total cost. \$30,000.00.

Vice-Mayor Hutton seconded the motion on the foregoing resolution and the vote resulted as follows:


