### INNOVATIONS IN INVASIVE SPECIES MANAGEMENT CONFERENCE

In mid-December, Mayor Hunt participated in a conference at Opryland attended by over 350 individuals representing state parks, national parks, cities, horticultural societies and vendors of invasive species management techniques and equipment.

Steve Manning, President of Invasive Plant Control of Nashville, coordinated and managed the event. We thank Steve for his commitment to this event and to WeedWrangle®. More about this later. Several Nashville entities were represented; Garden Club of America (Cayce McAlister), Cheekwood (Peter Grimaldi), Nashville's WeedWrangle® (Carter Dawson), Friends of Warner Parks (Elizabeth Lamar) and others.

Cayce McAlister opened the afternoon session on December 14th with a presentation "Organizing a WeedWrangle® in your State".

Mayor Hunt followed Cayce expanding on the Weed-

Wrangle® initiative with a presentation entitled "Invasive Species Management in an Affluent Urban Area". He noted that while the City of Belle Meade maintains its properties free of most invasive species, there are plenty of opportunities to educate and communicate the need for management to homeowners and other private residents of the city. Belle Meade Plantation, for example, could recruit volunteers to clear the invasive plants in the area bordering Richland Creek at Leake Ave and Harding Road. St. George's Episcopal and Immanuel Baptist Churches could recruit their members to eradicate honeysuckle, privet and other species on their properties. The Temple could clear their property along Richland Creek and compliment the Belle Meade Plantation's efforts. Once these initiatives are underway and publicized, the individual homeowner would be encouraged to do the same with their properties.

The day set aside for WeedWrangle® in Nashville is Saturday, March 3, 2018. **FROM THE POLICE DEPARTMENT – CHIEF TIM EADS:**



I hope everyone had a wonderful and safe holiday. If you have to be out during snow and ice conditions, please remember these DRIVING TIPS:

- Allow extra time to reach your destination
- Leave plenty of room to allow for long stopping time or to avoid stalled vehicles
- Turn on your lights to increase visibility for yourself and other motorists (All types of weather)
- Do Not use Cruise Control
- Remember bridges and overpasses will typically freeze first
- Keep a blanket in your vehicle in case you become stranded
- If you begin to skid, remain calm, release the accelerator, carefully steer in the direction you want the front of the vehicle to go and apply pressure to the brakes if you have ABS. If you do not have ABS (anti-lock brakes) gently pump the brake pedal in attempt to keep the wheels from locking up. If your wheels are not rolling, you will not have control of your vehicle.

**SAFETY TIPS FOR THE NEW YEAR:**

- Set your home alarm system any time you are away. Arm the exterior when you are sleeping.
- Prepare an inventory of your valuables. Photograph and record the serial number of items that have them. This greatly increases the chances of recovery and prosecution should you have a theft, or if you have to file a claim for fire damage or theft.
- Park Smart by locking your vehicle and removing or placing items of value out of sight or in the trunk.
- Call in suspicious activity when you observe it - 615-297-0241.
- Be aware of scams that occur daily by phone, in person and internet. If you are concerned that something is a scam, please contact us. He can do a public background check to verify references.

The Police Department is pleased to announce that Officer Tyler Parrish graduated from the Tennessee Law Enforcement Training Academy on December 21st, 2017 as a Certified Police Officer. Officer Parrish joined the police department as a part-time dispatcher in October, 2013 and became a

full time dispatcher on January 1, 2016. He performed his duties very well and is good with people. When Officer Norm Shelton announced his retirement in the spring of 2017 Officer Parrish requested to be considered to replace Officer Shelton. Officer Parrish has a few more weeks of field training before being assigned to a permanent shift. He is looking forward to serving the residents of Belle Meade in his new capacity.

Congratulations to Finance Director Aspen Collins, who completed the requirements for the mandatory Certified Municipal Finance Officer (CMFO) certification from the State of Tennessee. This program usually takes two years to complete, but Aspen successfully tested out of several components to complete the program in less than one year.



The Municipal Finance Officer Certification and Education Act of 2007 (TCA 6-56-400 et al) (the Act) requires municipalities to have a chief financial officer, who is either a Certified Municipal Finance Officer (CMFO), or an individual who is exempt from the educational requirements leading to the CMFO designation, such as a CPA. CMFOs must complete state approved training each year to maintain their certification.

## STORMWATER INFRASTRUCTURE IMPROVEMENT PROJECT

The City will be improving the stormwater infrastructure in the vicinity of Iroquois Avenue and Belle Meade Boulevard as budgeted for this fiscal year. The primary purpose of this project is to re-route stormwater flow to the right-of-way from where it currently crosses private property and flows under a house. The

City's engineering consultant, Steve Casey of CEC, Inc., will perform the survey and design work and assist City staff with bid preparation. Construction is scheduled to begin late spring 2018.
