## Resolution 1958-01

The Mayor stated that the sole matter for consideration at this meeting was the execution of a purchase order directing the Interstate Construction Company of Nashville, Tennessee, to undertake certain work in connection with the roads and streets of the City of Belle Meade. The Mayor stated that the Interstate Construction Company was presently under contract to furnish materials and labor at certain specified prices, including asphalt at 20 cents per gallon, crushed stone at \$4.25 per ton and gravel at \$4.50 per ton, including the cost of putting same in place. The Mayor further announced that the Interstate Construction Company had made a firm estimate of the price of doing certain repair work which had been inspected and considered by the Beard of Commissioners. The Mayor then read to the meeting the proposed items of repair and construction as recommended by Interstate Construction Company and, after discussion, upon motion duly made, seconded and woted upon, it was unanimously

RESOLVED, that the following items of repair and construction be undertaken by the City of Belle Meade and that Interstate Construction Company be directed to commence same in accordance with the terms of contract presently in effect between that Company and the City as to unit prices, the sum of SEVENTEEN THOUSAND FIVE HUNDRED DOLLARS (\$17,500.00) having been appropriated for such repair and construction, and the City Treasurer having certified that sufficient funds are on hand in the treasury or will be forthcoming in time to make such payment:

Section 1 - Jackson Boulevard from Belle Meade Boulevard east to Belle Meade Boulevard at Warner Place, 13,160 square yards mixed in place and seal coat - estimated cost - \$7,620.60.

Section 2 - Tyne Boulevard from the easterly city limits to Belle Meade Boulevard, 6,562 square yards mixed in place and seal coat - estimated cost - \$3,797.20.

Section 3 - Excavate for new base and dispose of excess material, construct 8-inch penetration base of stone and asphalt on the following: (a) Tyne Boulevard at Belle Meade Boulevard 107 square yards; (b) 1 - Lynwood Boulevard in front of Albert Feldman 70 square yards; in front of Charles B. McClellan 33 square yards; in front of Ralph W. Harrison 194 square yards; (c) 1 - Jackson Boulevard at Gerald Place 33 square yards; at side of residence of Mrs. Marshal Hotchkiss 44 square yards; at side of John W. Templeton 42 square yards; total square yards 523, estimated cost \$1,594.30 - total estimated cost \$13,012.10.

The Mayor thereupon ordered the resolution spread upon the minutes and directed the City Manager to instruct the Interstate Construction Company to proceed with the road program as approved hereinabove.
