

RESOLUTION NO. 84-03 A

A RESOLUTION APPROVING A CONTRACT FOR
RENOVATIONS TO BELLE MEADE CITY HALL

BE IT ENACTED BY RESOLUTION OF THE COMMISSIONERS OF THE CITY OF BELLEMEADE

That the base bid of Anderson Construction Company, in the amount of \$97,000/96 consecutive calendar days, reserving the right to accept or reject alternates as shown in said bid, for renovations to Belle Meade City Hall in accordance with specifications dated April 6, 1984 and prepared by Taylor & Crabtree/Wiley & Wilson architects is hereby approved and the Mayor is authorized to execute an appropriate construction agreement containing the terms of such bid. •

2. This Resolution shall take effect from and after its adoption, the welfare of the City of Belle Meade requiring it.
