
AUTHORIZING MUTUAL ASSISTANCE AGREEMENT WITH

BE IT RESOLVED by the City of Belle Meade, as follows:



MUTUAL AID AGREEMENT  
BETWEEN THE CITY OF BELLE MEADE  
AND  
THE METROPOLITAN GOVERNMENT OF NASHVILLE AND DAVIDSON COUNTY  
FOR  
POLICE SERVICE IN PERCY WARNER PARK

IT IS HEREBY AGREED to on this \_\_\_\_\_ day of \_\_\_\_\_, 1993, by and between the CITY OF BELLE MEADE and THE METROPOLITAN GOVERNMENT OF NASHVILLE AND DAVIDSON COUNTY (THE METROPOLITAN GOVERNMENT):

WHEREAS, Tennessee Code Annotated, § 6-54-307, authorizes inter-local agreement between cities, towns and counties regarding law enforcement services; and

WHEREAS, it is to the mutual benefit of the City of Belle Meade and the Metropolitan Government that the City of Belle Meade provide law enforcement services within the area of Percy Warner Park to supplement such services provided by the Metropolitan Government.

NOW THEREFORE, it is agreed as follows:

(1) The City of Belle Meade agrees, and is authorized by the Metropolitan Government:

To enforce laws of the State of Tennessee and the Metropolitan Government ordinances within the boundaries of Percy Warner Park, under such schedules and limitations as the City of Belle Meade may determine, considering its primary obligation to provide law enforcement services within the Belle Meade Corporate limits.

(2) This Agreement is terminable at will by either party upon notice to the other.

(3) Any officer or employee of the Belle Meade Police Department or any officer or employee of the City of Belle Meade, while engaged in any duty or activity in connection with the provisions of this Mutual Aid Agreement, shall be entitled to all rights, privileges, exemptions and immunities as if such duty or activity

were performed within the corporate limits of Belle Meade.

4. The City of Belle Meade further agrees, that any officer or employee of the Belle Meade Police Department, or any other officer or employee of the City of Belle Meade, while engaged in any duty or activity in connection with the provisions of this Mutual Aid Agreement, is acting within the scope of his or her employment for the City of Belle Meade. The City of Belle Meade shall be liable for such officer or employee to the extent that governmental entities are liable for the acts of their employees.


