

ORDINANCE 82-6

AN ORDINANCE TO REGULATE AND CONTROL THE USE OF ROADWAYS DESIGNED PRIMARILY FOR VEHICULAR TRAFFIC BY PEDESTRIANS, RUNNERS, JOGGERS AND OTHER INDIVIDUALS; TO DECLARE THE VIOLATION OF THIS ORDINANCE A MISDEMEANOR; TO PROVIDE PENALTIES FOR SUCH VIOLATIONS; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

BE IT ORDAINED BY THE CITY OF BELLE MEADE AS FOLLOWS:

SECTION 1. No person shall run, walk, jog, cycle on or otherwise use or occupy any street or roadway within the City of Belle Meade except when wearing clothing or devises capable of reflecting light during the period from one-half (1/2) hour before sunset to one-half (1/2) hour after sunrise and all other times when vehicles are required to display lighting equipment.

SECTION 2. Every person running, walking, jogging or otherwise traveling by foot upon a street or roadway shall remain as close to the left side of the street or roadway as practicable, opposing vehicular traffic, exercising due care for their own safety.

SECTION 3(a). Every person operating a bicycle upon a street or roadway shall ride as near to the right side of the roadway as practicable, moving with vehicular traffic, exercising due care for their own safety and the safety of others.

SECTION 3(b). Persons riding bicycles upon a street or roadway shall not ride more than two (2) abreast.

SECTION 4. Any person found guilty of a violation of this ordinance, or any provision thereof, shall be deemed guilty of a misdemeanor and subject to such penalties as may legally be imposed on account of such violation by the Recorder's Court of the City of Belle Meade.

SECTION 5. All ordinances or parts of ordinances in conflict herewith are hereby expressly repealed.

SECTION 6. Severability. The provisions of this ordinance are hereby declared to be severable, and in the event any portion or section hereof shall be invalid by any Court having jurisdiction

to make such determination, then such invalid portion shall be stricken and the remainder of this ordinance shall remain in effect, it being the intention of the Board of Commissioners to have enacted herein only such portions of this ordinance as shall be deemed valid and constitutional.
