Building Official Lyle Patterson compiled an annual summary of building permits fees since 1995 to the present. In 1995, 73 permits were issued totaling \$23,688.18. The highest year was 2017 for 160 permits totaling \$174,165.00. 2018 year-to-date for 94 permits is \$104,224.00. Mr. Patterson also reported we have 298 swimming pools in the City. Jackson Blvd, Chickering Road and Lane are the streets most populated with pools.
