2. Jackson Blvd. Speed Table Pricing and Placement Location

Residents opposed to the speed tables on Jackson Blvd.:

218 Deer Park Cr.; Richard Jones 220 Deer Park Dr. - prefers lowering the speed
limit.

Chief Eads stated that the traffic engineer states the speed tables should reduce speed and deter traffic. The Police Dept. will do a traffic count study on Deer Park Circle & Drive before and after the installation of the speed tables to determine if the tables divert traffic to those streets.

Mayor Jim Hunt said he the commissioners have received 23 emails regarding this Speed Table. 14 against and 9 for it most opposed live on Deer Park and those for the speed tables live on Jackson Blvd. He says that safety is the City's main concern and then closed the public comment period.

Director Larry Smith recommends the City's Street Maintenance contractor, Gibbs Brothers Construction Co., for the installation of the asphalt speed tables. The cost for installation is \$2,700 each and the removal is \$1,014 each. Director Smith explained that the asphalt tables are much less expensive than the rubber ones and require less maintenance. Cathy Altenbern stated she would like to see four speed tables installed on Jackson as per the Traffic Engineers recommendation.
