VII. Legislation -

Ordinance 2019-1, Close, Vacate and Abandon the Right of Way
 Of Pendleton Avenue Between Its Intersection with the Right of
 Way of Lynwood Blvd. and Its Terminus in the Turner Sub-Division
 First Revision, including settlement proposal, on first reading.

Attorney Alex Lewis states that if all three neighbors agree on a plan and sign the settlement proposal, then the Commissioners can take action. A settlement proposal signed by all 3 parties was submitted at the meeting.

2. Ordinance 2019-2, Amending Section 11-812 of the Belle Meade Municipal Code to Increase Court Costs for Various Moving Traffic and Other Offenses in Violation of Ordinances of the City of Belle Meade, on second reading.

At their budget workshop, Commissioners asked the staff to research court costs in surrounding cities, and recommend an increase based on what other courts were charging. Staff recommends an increase from \$51 to \$75.

3. Ordinance 2019-3, Amending Certain Sections of the Belle Meade Municipal Code and Zoning Code to Clarify Restrictions Concerning Signs, on second reading.

Mr. Berry explained that temporary signs are free speech and constitutionally cannot be prohibited. Commercial signs are not included in this ordinance and would still be prohibited. This ordinance must go the Planning Commission before the second reading by the Commissioners.

Motion to Defer 30 days: Moore Second: Bryan Vote: All aye

4. Ordinance 2019-4, Amending Section 11-408 of the Municipal Code to Specifically Regulate Fans under the City's Anti-Noise Regulation, on first reading.

5. Ordinance 2019-5, Budget Appropriations for Fiscal Year 2019-2020, on first reading.

Motion to approve: Moore Second: Bryan Vote: All aye

6. Ordinance 2019-6, Fix Tax Rate for the City of Belle Meade for Fiscal Year 2019-2020, on first reading.

Discussion followed regarding the fund balance and how much is undesignated and/or restricted, whether the property tax should be increased gradually as the Hall Tax is eliminated, or delay an increase until next year.

Commissioner Weigel proposed increasing the property tax to .30 cents, from the current rate of .25705 cents per \$100 of assessed value.
