Date	Incident	Address	Description
9-14-2020	LPR/Stolen Vehicle	Harding Rd & Lynwood Blvd	We received a LPR hit on a stolen vehicle. We found it near the Hwy 70/100 split but when they saw us they took off. We did not pursue but did notify Metro Police.
9-14-2020	Assist Citizen	Belle Meade Blvd & Forsythe	Officer stopped to check on a disabled vehicle. They had a wrecker coming and were not blocking the road.
9-14-2020	Safety Hazard	300 Block of Lynwood Blvd	Officer rolled upon a truck blocking the road. They were unloading and got flaggers to assist with traffic.

9-17-2020	LPR/Stolen Tag	Harding Pl & Enquirer Ave	We received a LPR hit on a dealer plate but was unable to locate the vehicle it was on. We found out later that the tag had been entered incorrectly, so the correct was entered and this one was removed.
9-18-2020	Officer Investigation	4000 Block of Shepard Pl	We received a complaint of loud music so We asked the residents to turn it down.
9-18-2020	Suspicious Vehicle	900 Block of Westview Ave	A resident called about a suspicious vehicle that was sitting in her driveway and asked was to check it out. We made contact and it turned out to be an Uber driver picking up a passenger that was leaving the house next door.

We had dispatch run the subject for warrants which turned up one out of Metro Nashville for criminal homicide. The subject was taken into custody and turned over to the detective working the case.
9-20-2020	Officer Investigation	200 Block of Deer Park Circle	We received a complaint of construction work going on and loud machinery being used. We made contact with the company grinding up a dead tree and warned them about the city ordnance and shut them down
9-20-2020	Assist Citizen	Harding Rd & Lynwood Blvd	Officer assisted a homeless person.
