Date	Incident	Address	Description
9-21-2020	Officer Investigation	200 Block of Deer Park Circle	We received a complaint about illegal parking. A moving van was warned about taking up too much of the road. They moved to the driveway.
9-21-2020	Assist Citizen	200 Block of Belle Meade Blvd	We assisted with unlocking a vehicle.
9-21-2020	Assist Citizen	300 Block of Lynwood Blvd	We assisted a motorist that had ran off of the road.
9-21-2020	Officer Investigation	400 Block of Lynwood Blvd	Metro Nashville Police Dept. asked us to check the welfare of residents after they received a 911 call. The officer arrived to find a 12 year old that was home alone briefly and felt scared. The officer spoke to the child and mother who arrived just as the officer did and determined everything was okay.
9-22-2020	Assist Citizen	4300 Block of Glen Eden	Had a resident stop by station to talk to an officer about an incident that occurred.
9-22-2020	Officer Investigation	Harding Rd & Davidson Rd	We responded to a possible kidnapping in progress but the vehicle had left prior to our arrival.
9-22-2020	Suspicious Person	800 Block of Westview Ave	We responded to a suspicious person that was spotted walking near a house under construction with a flashlight. The residence was cleared and nothing appeared to be disturbed.
9-23-2020	Officer Investigation	600 Block of Jackson Blvd	We received a complaint from a resident advising that they thought they heard heard someone trying to open their back door. We checked the property and found no one.
9-23-2020	LPR/Missing Person	Harding Rd/Jackson/Lynwood Blvd	We received 2 LPR hits on a missing/suicidal subject. We were able to stop the vehicle and speak to the subject who advised that he was fine and had no intent of harming himself. We notified Metro to have the subject taken out of NCIC.

9-24-2020	Assist Citizen	Harding Rd & Hillwood Blvd	We assisted a motorist who was needing directions.
9-24-2020	Assist Citizen	Belle Meade Blvd & Page Rd	We assisted a motorist with a dead battery.
9-25-2020	Officer Investigation	Forsythe Pl & Belle Meade Blvd	We responded to an abandoned vehicle on the corner with the hazard lights on. We stood by with the vehicle until the tow truck that the owner had called arrived.
9-25-2020	LPR/Stolen Vehicle	Harding Rd & Lynwood Blvd	We responded to a LPR hit on a stolen vehicle that crashed into a tree of a residence in the 100 block of Gilman Ave. The unknown suspects bailed out of vehicle and escaped. Contact was made with the homeowners and a crash report was made. Vehicle was towed to Metro tow-in lot.
9-26-2020	Officer Investigation	500 Block of Leake Ave	We received a complaint of someone illegally parked at park cutting trees. We checked the vehicle and it was a Metro Parks vehicle trimming branches.
9-26-2020	Officer Investigation	300 Block of Lynwood Blvd	We took a theft report of a political sign from the victim's yard. The detective was able to get tag information from the LPR and entered it into the LPR system.
9-26-2020	Suspicious Vehicle	Tyne Blvd & Belle Meade Blvd	We received a call about two vehicles parked on Tyne Blvd. The vehicles were two unmarked Metro Nashville Police units that were taking a report just outside the city limits so it was a false call.
