1. Request for Purchase/Install of Server & Computer Equipment

Asst. City Manager Aspen Collins advises the server, two switches and 16 computers are due for replacement. The server and computers will be bought from the State of Tennessee's VSPO contract with Dell for \$29,518.35, eliminating

the need to advertise and bid. The installation and service migration will be handled by Keystone Business Solutions for \$10,800. The switches are HP products purchased from CDW-G for \$902.53, which is under the threshold to obtain estimates. Total cost of equipment is \$41,220.88, which is under budget by \$2,964.12.

VII. Legislation -

1. Ordinance 2019-7, Amending Title Two of the Belle Meade Municipal Code to Create the Historic Zoning Commission, on second reading.

Building Inspector Lyle Patterson gave a presentation on the increased number of homes being torn down and what is being built back in their place. In many cases, we are seeing spec builders backed by investors who sacrifice quality in construction in order to make a quick profit. Lyle is seeing plans from the same architects with different builders on many spec houses. They often incorporate a steep pitched roof, painted white brick, wing walls and black framed windows, similar to the style at Alys Beach in Florida. These houses are lacking in original design, and some interiors are not up the standards of Belle Meade. We are losing the tradition of custom designed and built homes that add character to Belle Meade.

With the help of Jane-Coleman Cottone, Historic Preservation Specialist from the Tennessee Historical Commission (THC) we will explore the Historic Zoning. The Commission offers free assistance to inventory and catalogue every home in Belle Meade so that overlay districts can be established and design guidelines can be developed. The THC has already finished cataloging our city. Their results show Belle Meade is 63% Historic, but with many architectural styles. This is a good thing! THC will help educate the City on the process of surveying each house for design, year built and style. THC will assist the newly appointed members of Belle Meade's Historic Zoning Commission (HZC) as well as provide guest speakers for public meetings.

Belle Meade will implement its own plan and rules. THC will help us preserve the City. The City will have its own power and plans to enforce the least restrictive overlay. Staff wants this to pass so we can begin the conversations and planning process. Our zoning laws will stay the same using the BZA and MPC.

Commissioner Rusty Moore stated he is not against spec builders or teardowns but is for the option to control quality of buildings, not style. This approach is better for the City with conservation versus preservation overlays.

Haley Dale, 601 Enquirer Avenue, very supportive of the Ordinance Mark Poe, 223 Deer Park Circle - for the Ordinance; as a builder, sees lower quality in spec built homes Margaret Lovett, 604 Lynwood Boulevard - can't Lyle handle this in the office? Charley Thornburg, 229 Deer Park Drive - Worries about design, and profit margin for the builders will be reduced, so maybe the bad ones will leave. $\mbox{M/M}$ Kloeppel, 506-C Park Center - worried about too many restrictive rules Nate Greene, 1018 Chancery Lane - Will this stop teardowns? (No-regulate them) Erick Clifford, 712 Belle Meade Blvd. - for the Ordinance Gary Lee Smith, 220 Deer Park Circle, for the Ordinance

Prior to closing the public hearing, Mayor Hunt stated these are all ideas for the new Commission to address and we encourage input at future public meetings. If the majority doesn't want this, then the City won't proceed. Commissioner Moore clarified the City is not against spec builders, but it wants to preserve the character of neighborhoods.
