#### IV. Public Works

- 1. Monthly Reports submitted by Director Smith reviewed.
- 2. Final Settlement Agreement Concerning Pendleton Avenue. The City Board of Commissioners on June 26, 2019 passed Ordinance 2019-1, abandoning the right of way of Pendleton Avenue. The Allen's, 326 Lynwood Boulevard, would undertake the repaving, construction, and other remediation of Pendleton Avenue with the City paying \$5,000 to the Allen's to cover a portion of the cost and any amounts in excess thereof. The Allen's have completed all construction work on the driveway required by the City and such work has been inspected and approved by the City and found to be in compliance with all City ordinances and regulations.

Motion to approve the Final Settlement Agreement concerning Pendleton Avenue removing, reconstruction and installation of all landscaping in the green space required from the City, from the agreement:

3. Update on Haring Place Sidewalk Project - Phase 2

Hodgson Douglas Landscape Architects completed the plans and bid documents. The City has advertised for this project and posted the documents on the website. The bid opening will be held on Thursday, February 11, 2021. The staff will have a recommendation to award the bid at the February Commissioners meeting. Construction to begin as soon as weather permits. Completion prior to fiscal year end. The project is being funded with a portion (\$61,125) of the Local Revenue Grant funds received from the State of Tennessee. Grant requires funds be spent before June 30, 2021.

- 4. Belle Meade Together Master Plan Urban Transportation Planning Grant. The City of Belle Meade has applied for a \$70,000 Planning Grant to the Tennessee Department of Transportation. The Grant has been applied for and received by TDOT for fees related to studying the intersection at Harding Place and Lynwood Boulevard. If grant is received the City of Belle Meade is required to put up a 10% match of \$7,000.00 and adopt a resolution stating our intent to endorse the plan.
- 5. Millrace Lane Homeowner's Association Tee Zerfoss, current President of the Millrace Lane HOA and Doug Berry, City Attorney, have reviewed the HOA documents and determined that the Millrace Lane property owners are free to dissolve the HOA at any time and the City of Belle Meade has no regulatory or administrative powers over the HOA. Dissolving the HOA will not eliminate the Association's obligation for the landscape maintenance unless the City agrees to terminate this obligation. The HOA is requesting the termination of this obligation.

Motion to approve the request from the Millrace HOA to dissolve their HOA and they no longer be responsible for maintaining the landscaping in the right of way:

6. Update on the new NES Light Fixtures for Belle Meade Boulevard. Total Cost estimate to purchase and install 114 new light fixtures on Belle Meade Boulevard is \$463,259.03(Capital \$342,148.28, Installation \$121,110.75). No financing available. Options are to pay NES in full or pay a portion at the start of work and the completion of work. This would require a MOU.

Commissioner Bryan requests to defer this for one month to allow Belle Meade resident and Belle Meade Together Committee member Scott Kendall to review the sketch design.

Commissioner Moore asked Public Works Director Smith how many poles currently needed to be replaced and should we consider having them replaced before the installation of the new arm and light fixtures? Director Smith answered that NES maintains the poles. If a pole is replaced it is at no cost to the City. Beth Reardon stated that the City is billed an investment charge monthly for the 57 NES poles on the Boulevard and some on the side streets that we have light fixtures attached to and some with cameras.

Commissioner Bryan commented that we need to be careful when making these infrastructure changes without seeing exactly what all the options are. She does not believe we should initially let NES make any design or aesthetic decisions for us in Belle Meade.

Mayor Hunt stated NES is not making any pole decisions for us. We made the decision to take the other lights down and replace them with the new. The poles did not come into it because we assumed that NES would be using the same type of pole being used now.

7. NES Poles - Installation of new Fiber Lines - (images displayed) Public Works Director Smith stated the NES poles carry power, cable, and fiber. There are ten different fiber companies on the poles on Belle Meade Boulevard. We receive an exercise and franchise fee on those. Finance Director Leigh Mills stated for Franchise Tax annually in the budget is \$77,000.00.

Beth Reardon stated the City is not charged by NES for the removal of a light fixture on an old pole or the install of that light fixture to a new pole. The pole attachment fee is pretty standard, and we budget for it.

Director Smith stated there are two options for the poles, shiny silver, or rust.

Scott Kendall, 104 Clarendon Avenue, stated he had been on the call and wanted to say he has true experience with NES. There are choices. His concerns are not personal they are looking out for the City. The spine of our City is the Boulevard and he wants to make sure the design is the best among the options available. There are others that are high design experts in the Community, that live in Belle Meade that should consulted on this as well. He thinks it's worth exploring. Mayor Hunt commented we have already ordered and purchased lights.

8. Tentative Meeting with NES - Burying Power Lines on BMB The Commissioners will attend a meeting via "Zoom" with NES Friday, January 22, 2021 to discuss the possibility of burying the power lines on Belle Meade Boulevard.
