MINUTES

BOARD OF COMMISSIONERS OF THE CITY OF BELLE MEADE NOVEMBER 20, 2019

Call to order

The meeting was called to order by James Hunt, Mayor at 4:00pm.

Pledge of Allegiance - led by Mayor Hunt

Mayor Jim Hunt began the meeting with a moment of silence and respect for Mr. Tom Corcoran, Belle Meade resident and former Belle Meade Commissioner from 2002-2010, who passed away.

II. Public Comments -

Mathew Perkins, 414 Lynwood Boulevard, voiced his concern about the speed on Lynnwood Boulevard. He along with some of his neighbors have small children. He supports whatever is necessary to cut down on the speed and make a more friendly community environment for people to be outside and no danger of being hit when at their mailbox.

Stephen Kerr, 432 Lynnwood Boulevard, voiced his concern about the speed and traffic on Lynnwood Boulevard. He is very much in support of anything can be done to reduce it.

Kay Lang, 420 Lynnwood Boulevard, stated she and several of her neighbors have sent emails regarding the speed on Lynnwood and supports any measures that can be taken to reduce it. She has met with Chief Eads to discuss the speed and thanked the Commissioners and Chief Eads for taking their concern seriously.

William Robertson, 408 Lynnwood Boulevard, expressed his concern of speed on Lynnwood Boulevard and drivers not paying attention. He is requesting something be done to control the speeding.

Chief Eads addressed the Public and Commissioners about the speed issue on Lynnwood Boulevard. He agreed that the volume of traffic and speed has increased. The average speed through Lynnwood is about 29.5 miles per hour. When you look at the 85th percentile it is a little higher than it should be, at 34 miles per hour. One lane is a little faster than the other. Chief Eads suggests we try something on a temporary basis that is inexpensive. If the data shows it is effective, we can stay with that measure, then look for something more permanent. The Department received a grant allowing them to hire a parttime police officer. His primary duty is speed enforcement and safety. He has been working the 400 block of Lynnwood as well as other streets that have serious speeding and cut-through issues.

Mayor, Hunt said citations are the first thing to do to help educate people with the speed. The Commissioners are preparing other options that will have an effect on lowering the speed and perhaps some volume on Lynwood

Vice Mayor Bryan explained the problem with just relying on enforcement is that many cars coming through Belle Meade are not Belle Meade residents and they are not aware that Belle Meade has a history of enforcing their speed limit very forcefully, so their behavior will not change. The installation of traffic calming measures can change the behavior immediately. The result is the traffic slows down.

Mayor Hunt mentioned delineators as a quick and easy solution as we are working on a traffic study. Speed humps could be considered. Vice Mayor Bryan added that the speed bumps are more expensive and permanent. They have received mixed reviews on the speed humps on Jackson Boulevard.

Belle Meade resident Tom Starkey, 420B Lynnwood Boulevard, commented he does not care if others do not agree or like the measures taken to reduce the speed if it will make Lynwood Boulevard safe. Mayor Hunt closed the discussion saying the City will do something and for the residence to be at ease.

District 23 Councilman, Thom Druffel, was introduced by Mayor Hunt. He reported on the first Community Meeting, which Commissioner Moore attended, and the financial condition of the City of Nashville.
