II. Public Comment -

Metro Council member Thom Druffel gave an update on Metro Council activities and stated he is initiating a District 23 Partnership Council made up of the ten or so neighborhoods in the District. The purpose of this council is to identify and address common needs as well as build community relations. He encouraged a Commissioner to represent Belle Meade and come to the quarterly meetings. Commissioner Moore volunteered to do this.

Neighbors from Lynwood Blvd. between Abbott Martin and Glen Eden spoke about the increased volume and speeding issues on Lynwood. Present were Kay Lang, 420 Lynwood, Jennifer Johnson, 419 Lynwood, and Tom Starkey, 420B Lynwood. They requested the Commissioners institute some traffic calming measures to make their street safer. Three traffic studies have been completed and the police do make an effort to patrol and give tickets, but they cannot be on Lynwood enough to make a permanent difference in speeding and traffic volume.

CEO of Cheekwood, Jane MacLeod and Peter Grimaldi, VP of Gardens & Facilities, did a presentation for the Bracken Foundation Children's Garden that is under construction, and asked the City to consider a donation for this project of \$25,000 that could be paid in a lump sum or over several years.
