FROM MAYOR HUNT: Recap of Commissioner Retreat - February 24-25, 2021



The Commissioners, City Manager and Assistant City Manager held intense day and evening sessions at the “Loft” at Belle Meade Historic Site on February 24th and 25th. Agenda items included: Zoning Codes; Communications – to residents and between boards and commissions; potential candidates for future boards and commissions; City budget; Master Plan (Belle Meade Together); Parmer Park potential and strategy; City Beautification; Police Department; City vehicles; Neighborhood Watch and resident databases; Historic Zoning Commission; Stormwater update including rates.

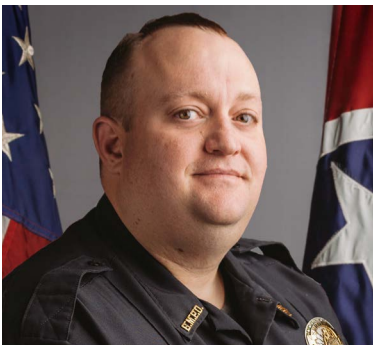
While these were not voting meetings, discussion proved enlightening on particular topics: (1) overall review of current zoning ordinances, especially Special Exceptions, Conditional Uses and Variances, lot sizes, training of new board members. This led to need for updating and clarifying entire set of ordinances. (2) 2021-2022 income and expense budget

considerations in light of Hall Tax phase out (3) New Chief of Police selection process (4) Exemplary Service Award funded by gift from David and Cindy Wilds (5) Combining of the three sources of City resident information: EMMA, Neighborhood Watch and Property Tax/Stormwater. Utilizing intern to coordinate the merger of these resources. (6) Video Surveillance – additional cameras to cover current weaknesses in coverage (7) Exploring better methods of disseminating emergency notices (8) Sneak preview of potential traffic calming ideas presented by Louise Bryan with lengthy discussion of progress of the Belle Meade Together plan reveal this spring and early summer (9) City Attorney position – need for annual review, job description, expectations. (10) Consistent email “signatures” for all employees and Commissioners (11) subtle messages as part of “signature” and website that will increase resident awareness of YouTube Channel, New Resident signup, resident comments, access to other City information with direct links to that information.

As you can tell, this was an important two days, with valuable ideas being discussed. Commissioners and staff will begin the work of studying and implementing these recommendations.



CONGRATULATIONS to Charles (Chuck) Williams, who transitioned from Sergeant to his new role as Police Chief for the City on March 3rd. Chief Williams has more than 18 years of law enforcement experience, with close to eleven years of service here at Belle Meade. A six-member Selection Committee (Mayor Jim Hunt, Vice-Mayor Rusty Moore, residents Jeb Beasley and Diane Lance, the City Man-

ager and Assistant City Manager) interviewed five very well qualified candidates - four from within the BMPD and a retired Deputy Chief from MNPD. Belle Meade Together Plan Update

Kimley-Horn has been busy, holding several meetings with City staff and Commissioner Louise Bryan and two meetings with the Steering Committee in February and March. The Kimley-Horn professionals (engineers, planners, architects, designers) held a “design sprint” for target areas in the City to collaborate on a number of design solutions for these areas that would address traffic calming, pedestrian safety,

stormwater, beautification and branding. The resulting recommendations were presented to both the team and Steering Committee to generate discussion, ideas and feedback on what will and will not work for the proposed Master Plan. The team and Committee members are also identifying several smaller projects that can be installed rather quickly after Plan adoption, but will yield a great benefit to the residents. There will be many more meetings in March and April, with the goal of having outreach and Plan reveal in May. Stay Tuned!

HARDING PLACE SIDEWALK – PHASE II

Construction of the Harding Place sidewalk at both the Lynwood Blvd. and Belle Meade Blvd. ends will begin in early April and should take 2-3 weeks to complete, weather permitting. The Board of Commissioners approved the low bid of \$77,900 for the project from Nsite, Inc. of Milan, Tennessee. They are the same contractors who installed the sidewalks in 2018. Hodgson Douglas Landscape Architects (HDLA) is

the City’s design consultant and will oversee the construction along with City Public Works staff. A portion of this Phase II project cost is being funded by the 2020-2021 State of Tennessee Local Revenue Grant Fund allocation. Plans are available for review at City Hall. point source pollution occurs when water from storms picks up pollutants and carries them into our rivers and streams. Many NPS pollutants are found around the home. These include household chemicals, yard waste (such as grass clippings and leaves), household trash, pesticides, grease, auto products, and excess nutrients (including fertilizers, septic system, and pet waste). We can control water quality by proper disposal of household chemicals, placing leaves and other yard waste in bags to be picked up by the City's brush and chipper contractor (never use streams or street ditches as disposal sites), using organic fertilizers, and protecting the

Many people think water pollution comes from factories and commercial sites. These are examples of 'point source' pollution. NPS or 'nonpoint source' pollution is actually the biggest factor affecting water quality. Non-
