## NEWSLETTER TO RESIDENTS OF BELLE MEADE APRIL 2021

### Belle Meade Together Plan Update



The Belle Meade Together (BMT) Master Plan is beginning to take shape. The planning consultant team from Kimley-Horn has been meeting regularly with Commissioner Louise Bryan, City Manager Beth Reardon and Assistant City Manager/Building Official Lyle Patterson as well as the citizen member Steering Committee to develop a “toolkit” that identifies the multitude of strategies to preserve, protect, and enhance the City consistent with its historic and pastoral brand image. This toolkit addresses five areas of emphasis:

- Beautification and branding
- Drainage and stormwater
- Public Spaces
- Walking and cycling
- Traffic calming and management

The toolkit is guided by four distinct principles that are derived from dialogue and input from staff, key stakeholders and residents.

1. **Less is More** – BMT honors the City’s unique and distinct history and character through understated design treatments.

2. **Streets as Places** – Street design should be as much about creating places for people as about moving vehicles.

3. **Speed is Fundamental** – Target speed is a conceptual approach to street design that identifies the highest speed at which vehicles should operate on a given street. Speed is the number one factor that determines the safety of a street. Target speed will be used as a tool for creating people-friendly streets in Belle Meade.

4. **Integrative and Creative** – the BMT Plan intentionally seeks out opportunities for creative solutions that integrate more than one strategy to achieve multiple objectives. For example, a median island can signify a gateway to the City, encourage appropriate vehicle speeds, provide a safe crossing location for pedestrians and incorporate stormwater drainage, all in a single application.

The consultants, key staff and the Steering Committee are making plans for public outreach in May to communicate the draft plan to the residents and obtain important feedback. Stay tuned for more information on website updates, a Virtual Town Hall meeting, a Listening Session at the Mansion and outdoor block parties as part of the BMT Plan reveal!



## Welcome, Spring.

### SPRING REMINDERS:

**BRUSH & CHIPPER SERVICE** - Brush & chipper service is contracted for roadside pickup of

bagged leaves and clippings, small limbs and normal yard waste debris. This service contract does NOT cover the pickup and removal of large trees that have been cut down on your property – that is the homeowner’s responsibility. If you set out a large amount of trimmings, the contractor may only take a portion on his weekly stop. The contract requires pickup of all residential properties and the contractor has a

limited amount of time that his crew can spend at each stop. Also, please do not bring yard waste to the dumpsters behind city hall.

**GARAGE / ESTATE SALE PERMITS** - If you are planning to have a garage or estate sale, you must first obtain a permit from the City. You may either stop by City Hall and complete the form or obtain it from the website, [www.citybellemeade.org](http://www.citybellemeade.org), under the “How Do I . . .” tab. The City does not charge a fee for this permit. You may post signs on the day(s) of the event at the property where the sale is being held.

**LAWN CARE REMINDERS** - Please remind your landscapers and lawn care services not to block access to the street with their vehicles and equipment while working. Also, they should not blow grass clippings and other yard debris out into the street, which is a violation of Belle Meade Code section 16-107. NOTE - If you have a sewer grinder pump, please make lawn service crews aware of the location of the green grinder tank lid, to avoid damage from mowing equipment.

**DOGS RUNNING LOOSE / BARKING DOGS** – With warm weather and pets being outside more often, the City staff receives an increase of complaints about dogs running loose or barking excessively. The City has ordinances prohib-

iting dogs from running freely in the neighborhood and disturbing the peace and quiet of a neighborhood with loud and frequent barking. Please be considerate of those living around you. The City will send a letter to the pet's owner requesting compliance with the ordinances if a complaint is received, but if violations continue, the owner can be cited to appear in City Court.

**WALK, JOG SAFELY** – Remember to walk, jog and bicycle single file: walkers and joggers against traffic and cyclists with the traffic flow. Per City ordinance, reflective clothing must be worn dusk to dawn, and bicycles must have warning lights on the front and back. Enjoy your time outdoors and be SAFE.



## FROM THE POLICE DEPARTMENT – CHIEF CHUCK WILLIAMS:

### SAFETY FIRST – BE ALERT WHILE WALKING & JOGGING



The Berry Hill Police Department assisted Metro Police on a couple of incidents involving men targeting women jogging alone. Berry Hill Police think the suspects are targeting young college students at Belmont University.



On one occasion, the suspect/ tried to grab a student while she was on her afternoon run. A second jogger was alerted to two vehicles near Walgreens on 12th Ave South that she believed was targeting her also. There have

been several vehicle descriptions given to law enforcement of suspicious behavior by joggers in the area. They range from smaller passenger cars to minivans.

During Easter weekend, a Vanderbilt student was the victim of an attempted kidnapping by a man on foot near the intersection of 21st Ave South and Grand Ave. around 9 p.m. She told Vanderbilt Police that the man grabbed her, but she was able to break free and run away.

Thankfully, all these women avoided harm and ran to safety. We are all aware of the dangers of distracted driving, but distracted walking/running can be equally dangerous. I encourage everyone that uses public roads to walk or run to be aware of their surroundings. Whenever possible, exercise with a friend or family member. If you see something that seems suspicious, report it to the Belle Meade Police Department at 615-297-0241 immediately. Stay safe!
