
FISCAL YEAR 2021/2022 BUDGET

The City’s budget is a legally binding plan on how it will use its resources over the next fiscal year. The 2020/2021 fiscal year that just ended on June 30th was the last year for collection of the Hall Income Tax. The Commissioners voted at their June 16, 2021 meeting to increase property taxes to compensate for the loss of the Hall Tax and achieve a balanced budget going forward. After much discussion and a public hearing for citizen comment, the Commissioners agreed to set the tax rate at .50 cents per \$100 of assessed property values. This increase allows the reserves to remain steady for capital projects and a cushion for unexpected changes in the economy. Additionally, the increase keeps the current level of services intact for residents.

The chart below illustrates where the City’s revenue comes from. Previously, the Hall Tax provided around 50% of the revenue stream while local property taxes provided about 30%. The City never knew how much the Hall Tax revenue would be each year until they received it, which made planning difficult. Now, almost 70% of the City revenue is predictable in the form of property taxes, making it much easier to prepare annual budget estimates and plan for the future.

A Sewer Rate Study was performed earlier in the year and it was recommended that the City implement a rate increase to cover increasing processing fees from Metro Water and Sewer. It has been 5 years since the City made any adjustments to the sewer rate. The budget reflects the recommended rate increase as well as the rising cost of expenses to maintain the sewer system. Capital projects for

the Sewer Fund include a Sewer Modeling/Sanitary Sewer Improvements project that will address high pressure issues in the system.

Capital Projects in the General Fund will largely be focused on projects from the Belle Meade Together Master Plan. Final presentation of the BMT Master Plan to the Commissioners will occur later this summer, and the hope is to complete several projects that will showcase the priorities of the Plan, including walkability, traffic calming, beautification and branding.

FROM THE POLICE DEPARTMENT – CHIEF CHUCK WILLIAMS




In 2020, thirty-nine pedestrians were killed by motor vehicles in Davidson County. Many of those killed were walking at night without reflective gear. Make sure you are wearing enough high visibility clothing/lights when you walk at night, and if walking your dog, have them wear a reflective collar, harness or vest.

Please remember that reflective clothing or a vest is required when walking or jogging on Belle Meade Boulevard or any other streets in the city. Belle Meade Code section 15-123 states this is always required during the period from ½ hour before sunset to ½ hour after sunrise

and when vehicles are required to have their lights on. The Code also stipulates walkers and joggers must walk AGAINST traffic. Click [HERE](#) to read Code Section 15-123, Jogging, Bicycling, etc.

We all know the dangers of the increased volume in Belle Meade, and our officers are enforcing traffic violations every day and night. Please be aware of your surroundings when you are walking or jogging in Belle Meade.

RECAP OF BOARD OF COMMISSIONERS' MEETING



The Commissioners took action on the following items at the **June 16, 2021** meeting:

- Approved the Parade Permit request for the Boulevard Bolt, Inc.
- Approved request to declare four Motorola Ticket Writers as surplus property.
- Approved the appointments of Charlie Rankin and Renee Stubblefield Poe to the Historic Zoning Commission. Ordinance 2021-2 amended the Belle Meade Code to increase the number of members on the HZA from five to seven. This allows for a quorum to be maintained if one or more members have a conflict of interest.
- Approved the appointment of Puneet Mishra as an Alternate to the Board of Zoning Appeals.
- Approved the following invoices over \$5,000:
 - o Kimley Horn & Associates Inc. \$ 8,035.00
 - o Local Government Corp. \$25,698.50
 - o Wascon, Inc. \$ 6,149.50
 - o Gibbs Brothers Construction \$ 7,220.00
(Jackson & BMB)

- Held a Public Hearing for comments prior to final reading of Ordinance 2021-3, to set the property tax rate in excess of the certified tax rate per the Metro Assessor's Office.
- Approved Ordinance 2021-3, Fix Tax Rate for FY 2021-2022. The property tax rate, after discussions with public and Board members, was set at .50 cents per \$100 of assessed value. This rate replaces the loss of Hall Tax revenue and allow for a balanced budget.
- Approved Ordinance 2021-1, Budget Appropriations for Fiscal Year 2021-2022.
- Approved Ordinance 2021-2, Increasing the Number of Commissioners on the Historic Zoning Commission from five (5) to seven (7).
- Deferred Resolution 2021-06, Budget Amendments for current Fiscal Year 2020-2021.
- Approved Resolution 2021-07, to Accept (voluntary) Donations from Belle Meade Citizens for the Purchase of Body Cameras for each officer and Automatic External Defibrillators (AEDs) for each Patrol Vehicle.


