

ORDINANCE 2021-2

AN ORDINANCE TO AMEND TITLE TWO OF THE BELLE MEADE MUNICIPAL CODE TO INCREASE THE NUMBER OF COMMISSIONERS ON THE HISTORIC ZONING COMMISSION FROM FIVE (5) TO SEVEN (7)

WHEREAS, the Commissioners of the City of Belle Meade pursuant to Ordinance 2019-7 created an Historic Zoning Commission for the City, as authorized by Tenn. Code Ann. §§13-7-401 to 13-7-409; and

WHEREAS, the Mayor of the City appointed five (5) persons to the initial Historic Zoning Commission; and

WHEREAS, Board of Commissioners finds that it would be in the public interest to have a larger Historic Zoning Commission of seven (7) members;

NOW, THEREFORE:

SECTION ONE: BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF BELLE MEADE that Section 2-201 of the Belle Meade Municipal Code is hereby amended to delete that section in its entirety and substitute the following therefor:

CHAPTER TWO

HISTORIC ZONING COMMISSION

2-201. Historic Zoning Commission. The Historic Zoning Commission (“HZC”) is hereby created, which shall consist of seven (7) members, which shall consist of a representative of a local patriotic or historical organization; an architect, if available; a person who is a member of the local planning commission at the time of such person's appointment; and the remainder from the community in general. The HZC shall be appointed by the Mayor subject to confirmation by the Board of Commissioners (“Board”). The terms of members of the HZC shall be five (5) years, except that the members appointed initially shall be appointed for staggered terms so that the terms of at least one (1) member but not more than two (2) members shall expire each year. All members shall serve without compensation. The HZC may adopt rules and regulations consistent with this part, as well as by-laws governing its own procedure, election of officers, agendas, and the like.

SECTION TWO: BE IT FINALLY ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF BELLE MEADE THAT THIS ORDINANCE


