	Belle Meade Together Demonstration Median	<ul style="list-style-type: none"> Per Commissioner directive, we must present three options on three medians based on Kimley Horn recommendations (See Document) <ul style="list-style-type: none"> › Will use Medians 36, 37 and 38 (three closest to Percy Warner Park) Must include signage and traffic calming elements of Kimley-Horn recommendations PATHWAY <ul style="list-style-type: none"> Need to flag out path, work around utilities and power poles. 4-5 feet wide Demonstration doesn't have to be ADA compliant, but final path does <ul style="list-style-type: none"> › Perhaps use concrete pavers for path, are pervious & ADA compliant › Could also just close cut grass to demonstrate path - cheap and grows out PLANTINGS <ul style="list-style-type: none"> Need to incorporate as many current plantings as possible (see Ceres BMB Recommendation) Demo plants will be from BMT recommendation list (see list) Will not put plantings along sidewalk demonstration, just median path Can do seasonal plantings prototype, also add daffodils for demonstration SIGNAGE <ul style="list-style-type: none"> Will include QR code to BMT webpage See graphic Questions for Commissioners <ul style="list-style-type: none"> Do we need to demonstrate the sidewalks? Does that require resident sign off for the yards we will use? For crosswalk demonstration, can we use heavy duty tape so don't put paint on road?
