FROM THE POLICE DEPARTMENT – CHIEF CHUCK WILLIAMS

In 2021, thirty-eight pedestrians were killed by motor vehicles in Davidson County. Many of those killed were walking at night without reflective gear. Please make sure you are wearing enough high visibility clothing/lights when you walk at night.

Please remember that reflective clothing or a vest is

required when walking or jogging on Belle Meade Boulevard or any other streets in the city. Belle Meade Code section 15-123 states this is always required during the period from ½ hour before sunset to ½ hour after sunrise and when vehicles are required to have their lights on.

We all know the dangers of the increased traffic volume

in Belle Meade, and our officers are enforcing traffic violations every day and night. Please be aware of your surroundings when you are walking or jogging in Belle Meade.

At the October Board of Commissioner's meeting several Belle Meade Police Personnel received the David and Cindy Wilds' Outstanding Service Award for the following event:

On 9/24/2022, BMPD received an LPR hit on a stolen vehicle. Sgt. Samol located the car at the Hwy 70S/Hwy 100 split. Upon activating his emergency equipment, the vehicle struck his patrol unit and fled the area. The pursuit was called off, however, the vehicle returned to Belle Meade where it crashed into another vehicle on Harding Rd/Jackson Blvd. The two occupants ran from the vehicle. Sgt. Samol and Officer Bowker detained the driver. Dispatcher Baldwin immediately notified Metro to activate the K9 units and their

helicopter. Sgt. Roark assisted the innocent party that was hit by the suspect's vehicle.

Officer Bowker assisted Metro K9 with the search and apprehension of the remaining suspect. Upon collecting all the evidence, it was discovered that the two suspects were armed with handguns, one of which was stolen, and more than one pound of marijuana.

Officer Parrish completed a total of nineteen warrants for both suspects.

Both dispatch and patrol worked very well together on this case and two criminals were apprehended thanks to their efforts.

IT'S TIME TO PLANT BULBS -- A LITTLE EFFORT IN THE FALL BRINGS A LOT OF BEAUTY IN THE SPRING

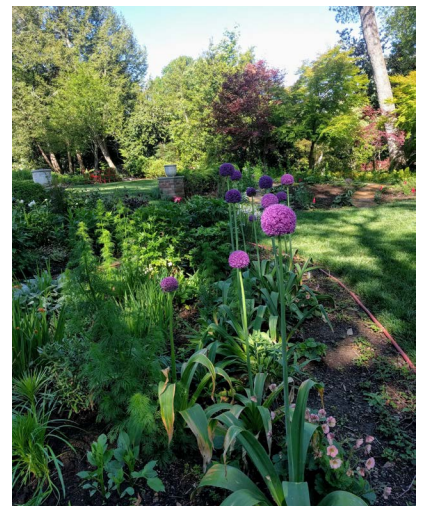


As Belle Meade residents, we are fortunate that every spring we can easily visit our neighbor Cheekwood to see acres filled with fresh, bright blooms from thousands of fall-planted bulbs. We can have spring color at home, too. If you haven't planted bulbs

before, now is the season to start. Daffodils and tulips are a good idea for beginners because their long stems make

them suitable for cutting and brightening grey days indoors. Alliums aren't good for cutting, but they are a great focal point in the garden.

There are some guidelines for bulb planting. Timing is important because you don't want bulbs to begin growing until

they have been cooling in the ground for a few months. In Nashville we usually plant in mid- to late-November when the weather is chilly, after a killing frost and before the ground freezes. The depth of the planting hole is another factor -- three times the height of the bulb is typical, so 6 inches deep for a large bulb. Bulbs perform best in areas that have good drainage and are sunny in early spring.

For detailed advice on planting, garden center staff members are happy to help. Online bulb vendors have a lot of illustrations, videos and tips. I have found these to be reliable sources:

RECAP OF BOARD OF COMMISSIONERS' MEETINGS

The Commissioners took action on the following items at the October 19, 2022 meeting:

- Approved construction bid for office renovations in the Public Works Building from Music City Electrical Engineering, LLC in the amount of \$35,400.00
- Approved a one-year contract extension for Street Sweeping with Road Runner Sweeping, LLC at the same contract price of \$1,520.00/month.
- Approved a one-year contract extension for Landscape Maintenance and Lawn Mowing with LSI at the same contract price of \$6,995.00/month.
- Approved three consultant proposals for the TDOT Multimodal Sidewalk Project in ranked order, and approved staff to proceed with contract negotiations with the #1 ranked firm.
- Approved the low bid for the 2022-2024 contract for Chipper Service, Brush & Leaf Collection from the two bids submitted, as follows:
 - o Parke Company \$21,000/month \$250/hour-emergency rate
 - o Clean Earth Collections \$15,700/month \$210/hour-emergency rate
- Approved a one-year contract with GOGov in the amount of \$2,400 for a notification and alerts mobile app program to communicate with residents. Four companies submitted bids as follows:
 - o Alert Media \$12,000 annual
 - o GOGov \$ 2,400 annual
 - o Hoplon \$ 6,000 annual
 - o Reach Alert \$ 1,240 first year, \$2,480 second and third year
- Approval of Invoices over \$5,000:

 - o Landscape Services, Inc. \$14,525.00
 - o St. of TN (payment to schools for mixed drink tax) \$11,037.50
