NEWSLETTER TO RESIDENTS OF BELLE MEADE MARCH 2023

ANNUAL COMMISSIONER RETREAT - 2023

The Commissioners held their annual retreat meetings on February 15-16. Department Heads from Police, Public Works, Building and Codes, and Finance were present to discuss their issues, ideas, and proposals for the upcoming year. Also present was new City Manager Jennifer Moody.

POLICE

- Change city-issued firearms from a standard duty caliber of 45 to smaller 9mm
- Hire additional F/T officer for 12-hour shift and move motorcycle officer to flexible 8-hour shift, 40 hrs./week to offer better use of this patrol option and more visibility at different times of day.
- Hire additional part-time, traffic-only patrol officer if grant funding is available
- Christmas Parade on Belle Meade Blvd. in conjunction with annual Santa on a Firetruck sponsored by Metro Council member Thom Druffel

PUBLIC WORKS

- Research and evaluation of the best pump types for our system. E-One and Myers pumps are currently used. PW Director is currently researching other manufacturers.
- State required Utility Training for all Commissioners now offered as online classes.

BUILDING & ZONING

- Revise Tree Ordinance. Add permit fee and inspection requirement to verify compliance. Notification to neighbors when permit issued.
- Permitting and Review Process Improvements, including watermarking of plans, documentation of all inspections, upgrading software to include ability for information to be accessible to staff, commissioners, contractors and residents and ability to produce detailed reports of all activities.
- Consider a different code codification vendor that allows changes to be made immediately, therefore Code is always up to date.
- · Recruit one new member on BZA and MPC

- Update by Vice-Mayor Dale on progress of zoning code re-write.
- Require state training classes for all BZA members. Currently, Belle Meade has opted out.

STORMWATER

- Encourage permeable pavers in water-prone areas instead of asphalt paving.
- Create a stormwater approval process for a group of neighbors jointly working on a solution.
- Create a guide for best practices to be used in design of stormwater compliance on site plans

FINANCE/HUMAN RESOURCES

- Online payment system with more payment options currently in progress
- Update Personnel Manual Leigh Mills and Jennifer Moody will work on this with MTAS
- · Re-establish process for annual staff reviews
- Discuss policy for deposits of excess funds currently city uses the Local Government Investment Pool (liquid) and CD Laddering Program with First Horizon. When to transfer, redeem CD's?

CAPITAL IMPROVEMENTS

- Belle Meade Blvd. left lane maintain pass/turn only with transitions, grooved pavement, additional conspicuous signage, or paint message on pavement
- Identify sidewalk project Lynwood Blvd.; from existing on Lynwood Terr. to Harding Rd.; other?
- Adopt and begin installation of a consistent design scheme for all signage in city create a unique look that is different from the rest of Davidson County.
- Consider speed humps/transitions on Gerald Pl similar to lower Jackson Blvd
- Develop a plan in conjunction with Beautification Committee to clear donated land near Hillwood Bridge of invasives. Consider signage signifying entrance to Belle Meade city limits.

BUILDING ACTIVITY REPORT

February 2023 building activity resulted in issuance of nine (9) new building permits, conducting 23 residential code inspections, and the abatement of two (2) code enforcement cases. Residents will soon see implementation of a new signage program that will identify the approved hours of construction for all projects

permitted by the City of Belle Meade. The signage will provide notice to neighbors that approved work may begin. Signs will identify the permit holder, project specific information on parking requirements, and restricted hours of construction, including that no work may be done on any Sunday or federal holiday.

Contractors may request an inspection appointment online at <u>inspectmyproject.com</u>. Files can also be uploaded to this site, as needed. All inspections are completed within 48 hours of an online request.

The City's Interim Building Official is Andrew Pieri of Municipal Inspection Partners. Beginning March 6, his office


FROM the BEAUTIFICATION COMMITTEE:
