Swearing In of new Commissioner Marty Dickens



The City of Belle Meade is honored to announce that Mr. Marty Dickens was unanimously appointed to fill the remaining, unexpired term of former Mayor and Commissioner Jim V. Hunt. Mr. Dickens will serve until August 2024. The next regular municipal election is scheduled for August 2024 when residents will elect

two Commissioners to serve new 4-year terms.

Marty Dickens brings a wealth of leadership experience to the City Commission and an similarly vast record of community service and involvement in bettering the community, particularly for children.

Marty retired in 2007 as President of AT&T Tennessee after serving in his position for nearly a decade. His career included time as Executive Vice President of BellSouth International, where he was part of a senior team responsible for overseeing the management and growth of BellSouth foreign operations. He has also served on the Board of Directors of the BellSouth operations in Brazil, Venezuela, Nicaragua, Denmark, Belgium, Israel, China and New Zealand.

He is a current board member of Pinnacle Bank and Smith Seck-

man Reid, Inc. and past chairman of the board of Blue Cross/Blue Shield of Tennessee, Lee Company and Harpeth Companies. He is a founding member of Avenue Bank and past chairman of the Nashville Area Chamber of Commerce, the Nashville Convention and Visitors Bureau and the Nashville Convention Center Authority.

Marty is most recently past Chairman of the Board of Trustees of Belmont University and has served on the board of Vanderbilt's Blair School of Music. He serves on the executive committee and is a past chair of the YMCA of Middle Tennessee. His other service includes involvement on many community boards, including the Baptist/St. Thomas Hospital Foundation

Board, Boy Scouts of Middle Tennessee, The Nashville Symphony, Adventure Science Center, the Arts and Business Council, PENCIL, Fellowship of Christian Athletes, and Family and Children's Services.

Marty and his wife, Betty, have two grown sons. John, wife Sherri, and daughter Ally Grace and son Bo live in Atlanta as do Jamey, wife Sara, and son Cashman and daughter Peyton James.

CRIME ALERT – Mail Thefts on the Rise Recently, Nashville and the surrounding areas have fallen victim to a new money-making fraud where criminals drive around looking for mail to steal out

of residential mailboxes. Use of flags to indicate that mail needs to be picked up may attract these criminals looking for a quick way to make cash. Belle Meade residents have experienced several mail thefts in recent weeks. The suspects are stealing mail, washing any checks in the mailbox, and cashing them. Many victims do not notice the name changed on the written checks. Therefore, it takes a long time before victims realize any loss occurred. However, we do have some good news! Belle Meade Police Detective Tom Sexton arrested two suspects and recovered mail from Belle Meade and the surrounding areas. This outstanding work will hopefully send a message to others attempting to commit crimes in Belle Meade. This case seems to involve several suspects operating across multiple states. Be proactive and consider taking any mailed checks inside the post office instead of putting checks in the mailbox at your residence. RULES FOR RECYCLING IN BELLE MEADE



YES - ACCEPTABLE RECYCLE ITEMS: (see above)

- > Paper, junk mail, newspapers, paper containers
- Cardboard boxes for cereal, crackers, paper towel and TP rolls, shipping boxes (small)
- ≻ Food and drink cans aluminum and tin
- > Plastic bottles, jugs, and jars ONLY no other plastics

NO - UNACCEPTABLE ITEMS FOR RECYCLE COLLECTION:

- Takeout containers, Styrofoam, plastic cups, plastic food tubs, OJ and drink cartons etc.
- Glass bottles, jars, etc. (You can take glass items to the Metro Recycling drop-off sites)
- ≻ Plastic bags, plastic wrap, bubble wrap
- > Pizza boxes, soiled paper towels or paper plates

PLEASE NOTE: If your recycle can contains a large number of unacceptable items, the entire contents will be thrown out with the trash and will not be recycled. The Davidson County recycle processor will not accept recycle loads from contractors who have large amounts of unacceptable items in the load.



RECAP OF BOARD OF COMMISSIONERS' MEETINGS



The Commissioners took action on the following items at the, June 21, 2023 meeting:

- Presented Police Officer David Read and Police Sergeant David Wright with the David and Cindy Wilds' Exemplary Service Awards.
- Approved Amendment 1 to a Grant Contract with the Tennessee Department of Transportation to redistribute

the grant funds, without any change the total awarded amount, for the Harding Pike Sidewalk Project. The project remains in the first of four project phases: 1) environmental review; 2) preliminary engineering design; 3) final design and bidding; 4) construction and project close-out.

- Approved a contract with NashComm for a mandated patch to update police radios.
- Approved a state grant award of \$666,588 from the Tennessee Dept. of Environment and Conservation for Sewer System Improvements estimated to total \$866,565, utilizing 23% local funds.
- Awarded a contract to Sanitech (under Sweeper Corporation of America), in the lump sum amount of \$37,569 for sewer collection system (gravity line) inspection and cleaning preformed every 5-years as part of the City's preventative maintenance program.
- Approved the appointment of Carter Dawson and Ashley Levi to the Municipal Planning Commission.
- Approved the reappointment of Erick Clifford and appointment of Ron Farris to the Board of Zoning Appeals.
- Approved the appointment of Ray Hayles to the Historic Zoning Commission.
- Received an update on the Belle Meade Connect App from the City Manager and nearly 500 residents have downloaded the app to-date.
- Approved the following invoices over \$5,000:
 - oLocal Government Corporation\$28,411.60oMunicipal Inspection Partners\$6,025.00
 - o Wascon Inc. \$ 7,389.56
 - o Wright (Flood Insurance Public Works) \$ 4,321.00
 - o Wright (Flood Insurance City Hall) \$11,184.00
 - o H.E. Parmer Company, Inc. \$14,662.00
- Received a presentation from Beth Thomasen and Steve Thompson with Burris, Thompson and Associates regarding their recommendations from the Employee Salary/ Wage Study.
- Received an update from the City Manager on the recruitment of a Planning Director with final interviews to be

held with a citizen interview panel on Friday, July 7 from 8am – 2pm at City Hall.

- Adopted Resolution 2023-05 amending Ordinance 2022-03 to provide for the increase or decrease in the various expenditure and revenue appropriations for the FY 2023 annual budget.
- Adopted Ordinance 2023-3 on final reading to appropriate funds for the FY 2024 budget year.
- Held a Public Hearing on the FY 2024 Property Tax Rate Ordinance 2023-4 (no change/increase in the property tax rate for FY 2024).
- Adopted Ordinance 2023-5 on final reading amending the Sewer Charges for FY 2024 (adopted a 2% increase for FY 2024 in accordance with the city's most recent rate study)
- Adopted Ordinance 2023-6 on first reading to clarify the number for a quorum of BZA members due to the recent change from 5 to 7 members.
- Adopted Ordinance 2023-7 on first reading to adopt plumbing and mechanical code and the international gas and mechanical code and provide for enforcement by the City of Belle Meade rather than Metro Nashville Codes.
- Adopted Ordinance 2023-8 on first reading to amend the Building Code for Buildings other than one- and two-family dwellings and provide for enforcement by the City Building Official independent of the State Fire Marshal.
- Adopted Ordinance 2023-9 on first reading to amend the Stormwater Ordinance to renumber sections that have previously been mis-numbered and amend provisions concerning billing, delinquencies, and collections.
- Adopted a settlement agreement with the Belle Meade Historic Site related to outstanding building permit matters.
- The Board of Commissioners next meeting will be held Wednesday, July 12th at 4:00 p.m.
