

## NEW UTILITY VEHICLE FOR COMMUNITY EVENTS

The City of Belle Meade Police and Public Works Department added a utility terrain vehicle (UTV) to our fleet. This smaller vehicle will aid in response to calls during community events and along greenways or unpaved areas, such as parks.

We anticipate this new resource will be used by the Police at special events such as the Nichol Lane Halloween Party, the Boulevard Bolt, and the Holiday Parade. Additionally, the UTV will be used to assist the

## New, Full-Time Building Official for Belle Meade

Following a re-organization at the City of Belle Meade, the City now employs both a full-time city planner and a full-time building official to support land development review, permitting and overall enforcement of local and state laws related to building projects in Belle Meade. Matthew Singleton is a state certified code inspector and started work on November 27th. He is responsible for reviewing all site and construction plans,

issuing permits, performing residential and commercial building inspections, and enforcing the city's ordinances on property maintenance, land disturbance, tree preservation, and stormwater. Singleton is from Conway, South Carolina and moved to the

## Updating Belle Meade's Zoning Ordinance

The Belle Meade Zoning Ordinance is the set of regulations that best contributes to realizing the quality and type of residential development envisioned by the Belle Meade community. This part of city code typically regulates land use, building size and placement, parking, landscaping and parcel size. These regulations use "districts" to allow different standards that best fit the existing character of different neighborhood areas within Belle Meade and define how property within the city limits may be developed or redeveloped.

The last comprehensive update to the Zoning Ordinance was in August 1997. In the past few decades, development patterns and desired uses have changed in some significant ways. The current Zoning Ordinance needs to be rewritten to better fulfill the vision to preserve the "thoughtfully curated" character and distinctly "beautiful city in a meadow" described within the Belle Meade Together Plan.

As a first step, an internal review team was formed consisting of Commissioner Haley Dale, Municipal Planning Commission member Larry Wieck, City Manager Jennifer Moody, Planning Director Mary Samaniego, in consultation with City Attorney Doug Berry. This taskforce of city officials has been working to complete a comprehensive rewrite of the code that uses plain language, illustrations and simple charts when applicable, and definitions of key words so that there is less variability in interpretation of how Nashville area in March 2022. He holds an associate degree in civil engineering and served in the US Army, including one tour in Afghanistan. He and his wife Allison are expecting their first child, a daughter, in March 2024.

The new building official position supports all construction related activities within the City and works in collaboration with the Planning Director, Mary Samaniego, who is responsible for the development and enforcement of policies related to land use and zoning in the City of Belle Meade and implementation of long-range plans, including the Belle Meade Together Plan. to carry out permitted activities within the code. The team has been meeting in work sessions open to the public since late August and intends to be ready for public comments on the new ordinance in early 2024. The draft ordinance will be made available on the city's website for review and comment as soon as it is available in the coming weeks.

Next, the new ordinance will be presented to the Belle Meade Municipal Planning Commission in a study session anticipated to be held in January 2024. Public comments will be accepted anytime by city staff and will be heard from the public during the study session. Finally, once a new zoning ordinance has been considered by the Municipal Planning Commission, it will proceed to a public hearing and consideration for approval by the Board of Commissioners. The Commissioners must vote on new ordinances on two readings, meaning at two separate board meetings, prior to the amendments or new ordinance taking effect. According to the anticipated timeline, a new zoning ordinance could be in effect by early spring 2024. Upon all approvals being granted, the new zoning ordinance is intended to be searchable electronically and easy to find in a prominent location on the city's website.

# **RECAP OF BOARD OF COMMISSIONERS' MEETINGS**

The Commissioners took action on the following items at the, the November 15, 2023 meeting:

- Denied approval of a proposed additional scope of work with KCI Technologies, Inc. totaling \$15,200, to provide traffic calming analysis and 30% design for the 400-600 block of Lynnwood Boulevard, which would have increased the total contract value from \$54,110 to \$69,310. Discussion on the denial was to complete the current contract and reconsider the additional scope as a part of a future proposal to complete full design of improvements approved by the Board of Commissioners.
- Approved an emergency expenditure with Dixon Plumbing, totaling \$5,000, for repair of electrical service to restore sewer service at a residence on Harding Place.
- Approved a software license agreement with CivicPlus for an online permit management system, for the initial year total cost of \$15,000.
