SECTION 1. The Resolution is hereby approved with the following insertions, modifications and changes:

Preamble:

The word "City Recorder" shall be substituted for the word "Secretary" in the first line.

The word "municipal" shall be inserted before the word "corporation" in the second line.

The words "Board of Commissioners" shall be substituted for the phrase "Board of Directors" in the fourth line.

Paragraph 2 AUTHORIZED SIGNERS FOR DEPOSIT ACCOUNT

The Mayor, Vice-Mayor, and City Recorder shall be authorized to act as authorized signers and shall provide the required information.

Paragraph 3 AUTHORIZED FOR INFORMATION ONLY

The Mayor, City Manager, and Finance Director shall be authorized to act in this capacity and shall provide the required information.

Paragraph 4 FACSIMILE SIGNATURES

The Mayor, Vice-Mayor, and City Recorder shall provide this information.

Paragraph 5 LOANS

This section shall be deleted and marked NOT APPLICABLE.

Paragraph 7 SERVICES AGREEMENTS

The Mayor, City Manager, and Finance Director shall be authorized to act in this capacity and shall provide the required information.

SECTION 2. The City Recorder is authorized to sign the Bank Resolution and to transmit it to the Bank along with this authorizing Resolution and a certified copy of Title 5, Section 1 of the Municipal Code.

SECTION 3. That this resolution shall take effect from and after its passage, the general welfare of the City of Belle Meade, Tennessee requiring it.
