### BELLE MEADE HONORED AT 2025 ENGINEERING EXCELLENCE AWARDS GALA

On November 10, 2025, Belle Meade's City Manager Jennifer Moody and Public Works Director Nathan McVay joined project engineers with LDA Engineering to accept an award for the City's digital asset management plan project. The award was presented by the Tennessee Engineering Foundation and the American Council of Engineering Companies (ACEC) of Tennessee. These awards honor engineering projects that demonstrate innovation, problem-solving, and improve communities.

Belle Meade's project, completed in 2025, has included many hours of field work in order to gather and digitally map the location, age, repair history, and other critical information from each physical part of the city's sewer system. Thank you to all Belle Meade residents for your cooperation as LDA engineers visited your properties, often including back yards, to locate the grinder pumps, sewer force mains or gravity lines on your properties.

The City's partnership with LDA Engineering empowered

the City of Belle Meade to take a major leap forward in sewer system management – transitioning from hard-copy records to a fully digital, geospatial asset management system. Using advanced GPS, ground penetrating radar (GPR), and ESRI GIS tools, LDA mapped over 65 miles of sewer lines and 900+ grinder pumps, delivering a real-time, feature-rich geodatabase and work order system that enhances operational efficiency, budget planning, and long-term asset lifecycle management. Further, maintaining this data in digital format creates the foundation for better, more proactive operations and maintenance of the system. Belle Meade's sewer infrastructure was first installed nearly 50 years ago, and with the completion of this project we have the tools for responsible management for the next 50 years.

During the awards ceremony, the City of Belle Meade was acknowledged as a model for smart, sustainable infrastructure management. The project's outcomes have added significant value to our city's management by increasing data accuracy, streamlining office-to-field workflows, automating maintenance and informing capital planning.

This project was funded largely with support from the Tennessee Department of Environment and Conservation (TDEC), State Water Infrastructure Grant (SWIG) program. The program's funds are available from the Tennessee's allocation of federal American Rescue Plan Act funds. The City's first-ever asset management plan is fully compliant with best practices and guidance available from TDEC and the State Comptroller's Office.

### CITY ADOPTS FIVE-YEAR RATE STUDY FOR SEWER SYSTEM

Belle Meade Commissioners reviewed results from a recent study recommending 4 percent annual increases in the Belle Meade sewer user rate for the next five years. The purpose of the study is to gain independent analysis of the system's income and expenses and to ensure that user rates are at a level that will support the operations and maintenance needed for continuity of the public system. In the previous study, the City was advised to increase rates by 10 percent in the first year following the study and by 2 percent each following year. On July 1, 2025, the City implemented the final 2 percent increase from the last five-year study and a 4 percent increase will be proposed for adoption in the next fiscal year budget for July 1, 2026. As proposed, a 4 percent increase in the rate would change the minimum monthly sewer bill by \$1.25 per month (from the current rate of \$31.24 to \$32.49).

Belle Meade's sewer collection system consists primarily of residential grinder pump systems at most homes that flow into pressurized lines maintained by the City before transferring into Metro-Nashville's sewer system for final treatment. The main recurring expenses for the system are in repair and replacement of grinder pumps and chemical treatment of lines to reduce corrosion and control odors in the system. The recent study highlighted that Belle Meade's system is nearly 50 years old and the likelihood of costly capital projects increases with the age of the system. Small, annual increases will ensure that the City has funds available for capital projects when needed. Last, the study reminds the City Commissioners that, unlike surrounding systems, our city has no expectation for growth or adding new customers that would significantly increase revenue, therefore raising user rates will continue to be a necessary adjustment to provide adequate income for the Belle Meade sewer system.

### NEIGHBORS WELCOME MOTHER DOE IN DEER PARK

Neighbors in the area of Deer Park Circle initiated a request to City Commissioners for permission to raise funds for installation of bronze deer statues in the public green space, also known as the Deer Park "pocket park", between Jackson Boulevard and Deer Park Circle. With their support, in just a few months, thirty-five (35) individual families contributed \$6,950 towards the effort. The Ceres Society accepted the donations on behalf of the City and neighbors. To date, the funds have supported the purchase of a mother doe statue that was installed in November 2025 and to cover expenses related to purchasing materials for the statue's base and the labor related to the installation. Mr. and Mrs. Raymond Pirtle, Jr. (Sandra)

and Carter Dawson coordinated the project with city staff and Clay Staley with Natchez Stone completed the installation work. Remaining funds of approximately \$1,500 are intended to be used to further enhance the area with perennial plantings.



## **EXPLORING BELLE MEADE HISTORY:** Douglas "Duck" Henry, Our First Mayor

Douglas Selph "Duck" Henry Sr. holds a special place in the history of Belle Meade. Serving from 1938 to 1940, Henry was the city's very first mayor and helped establish the foundation for the community we know today. Although best remembered locally for his civic leadership, his life story stretches far beyond Belle Meade.

Born on December 30, 1890, in Clifton, Tennessee, Henry attended Vanderbilt University, where he played both football and basketball. His athletic career was vigorous and varied; after briefly leaving school, he became the head football, basketball, and track coach at Birmingham College before returning to Vanderbilt as a player. He graduated with degrees in science and law. Henry went on to serve as a captain in the United States Army during World War I with the 18th Field Artillery of the 3rd Infantry Division. After returning home, he practiced law before beginning a

long career with the National Life and Accident Insurance Company. Over the decades he rose from assistant counsel to vice president, earning widespread respect in Nashville's business community. His public service included a term in the Tennessee State Senate from 1927 to 1928, representing Davidson County. A decade later, he became Belle Meade's first mayor, guiding the newly incorporated city in its earliest years. Henry passed away on September 3, 1971, at the age of 80, leaving behind a legacy of leadership, civic commitment, and community pride. His son, Douglas Henry Jr., continued the family tradition of public service as a long-serving Tennessee state senator.
